WHEREAS the Anguvigaq/RNUK submitted a request to NMRWB on December 11, 2023, to reassess the position of the Northern limit of the EHB Arc;

WHEREAS the NMRWB opened a public hearing on this topic on March 6, 2024;

WHEREAS Inukjuak knowledge holders met on April 10, 2024 and proposed a new position for the EHB Arc northern boundary as well as a voluntary closure for the area near Inukjuak from July 15th until September 30th:

WHEREAS the Inukjuak Anguvigaq/LNUK met with the council of the Northern Village of Inukjuak on May 10, 2024 to discuss this voluntary closure in more detail;

THAT: the preamble be an integral part of the present resolution;

THAT a voluntary beluga harvesting closure be implemented near Inukjuak from July 15th to September 30th on the condition that the proposed new boundary of the EHB Arc (south of Inukjuak) be accepted by NMRWB and DFO;

THAT a by-law be written by the Inukjuak Anguvigaq/LNUK to outline this closure, once the new EHB Arc boundary is accepted, and be supported by the Northern Village of Inukiuak:

THAT this voluntary beluga harvesting closure be communicated by radio to Inukjuamiut by the Inukjuak Anguvigaq/LNUK and to Nunavimmiut by the Anguvigaq/RNUK, and efforts will be made to educate harvesters on the purpose and reasons for this closure;

THAT If the recommendation for the new EHB Arc northern boundary (south of Inukjuak) is rejected or significantly modified by the NMRWB or DFO, this resolution will no longer be applicable and the Inukjuak Anguvigaq/LNUK and Inukjuak NV will need to reconsider this closure.
